TERMS & CONDITIONS

GENERAL BOOKING INFORMATION: Non-refundable deposit (\$ 350 p/person) is required at time of booking. All check must be payable to: **TIS Travel Inc.**, and for convenience, checks can be sent to St Paul Church in Tampa, to the attention of Rev. Morley. Reservation form with detailed traveler information & copy of passport must be attached to initial deposit. Fifty percent of trip cost is due 90 days prior to departure date. Balance of trip cost is due 45 days prior to departure. If a booking is made within 45 days of departure, full payment is required at time of booking. Returned checks will incur a \$25 service fee. Payments with credit card subject to 2% merchant fee. Unless specified on trip cost, not included in package price are Airline taxes & Fuel /Security fees (estimated \$ 695) and Tips to local personal (\$ 140 per person); drinks during meals, optional visits, entrance fees (unless specified), & items of personal nature such as telephone calls, mini bar, laundry, room service, luggage handling, excess baggage fees, passport or visa fees. Trip price is based on group travel. Program inclusions are as per detail information on flyer/brochure and considering Double/Twin/Triple room occupancy. All prices are shown in US Dollars and subject to change due to final number of participants & European currency fluctuation. Travelers must be in possession of an American Passport valid up to 6 months from return date. NON-AMERICAN passport holders must verify for Visa requirements. Air transportation is in economy class on IATA approved carriers and transportation is subject to the airline terms of carriage. Ticketing will be completed between sixty and forty-five days prior to departure.

CANCELATION POLICY: Initial deposit is non-refundable / Airline ticket is non-refundable, non-transferable and no changes or upgrades are permitted. Cancellations received 90 days prior to departure subject to the following penalties: From 120 to 90 days prior to departure = 25% of total trip value/ From 89 to 60 days prior to departure = 50% of total trip value, From 59 to 30 days prior to departure = 75% of total trip value/ From 29 days to departure day = 100% of total trip value as penalty.
